## **DIRECTOR'S REPORT**

- The Michigan Department of Health and Human Services distributed COVID-19 test kits to 18 libraries in Michigan. CADL was not selected for the program.
- CADL purchased N95 masks for staff. They are not required to wear them, but we wanted to have them available if staff wanted them. Currently, we instruct staff to follow CDC's masking guidelines which state to wear a well-fitting mask that protects you and is comfortable.
- The Michigan Library Association's Advocacy Day has been moved to virtual only on Tuesday, March I.
- CADL has been in contact with Mayor Schor's office regarding the resignation of Vern Johnson and the next steps for finding a replacement from the City of Lansing.
- The Winter Reading Challenge is taking place from January 18 February 28. The theme is "Reading for a Better World" and is open to all ages with small prizes and gifts for participants who read the required amounts.
- CADL started a promotional campaign titled "Fact or Fiction" that focuses on the value of having a library card and using library services.
- There has been a drop in the number of individuals having library cards. The total numbers will be shared in February during the Executive Director's Annual Report presentation.
